Spring Gala Celebrates Town's Centennial

The Chevy Chase Historical Society's 2018 Spring Gala was held on Sunday, April 29, and celebrated the 100th anniversary of the Town of Chevy Chase. The event was hosted by Lexi and Colin McKay at their home at 6800 Connecticut Avenue, one of the oldest homes in the Town. Built in 1921 on the corner of Rosemary Street and Connecticut Avenue, this gracious home is an excellent example of the larger houses built along the important Connecticut Avenue corridor during the early development of Chevy Chase. While the original designer is unknown, by the late 19th century many American architects had visited Italy and were familiar with the formal, symmetrical Renaissance palazzos. They designed similar houses in the United States through the 1930s, with flat or low-pitched hip roofs and classical features. With its traditional stucco finish and classic door and window surrounds, this house displays strong characteristics of an Italian Renaissance style home.

The McKay's spacious and hospitable home was previously the home of important Washington area residents, beginning with its original owner, Judge Alexander Mulloony. Judge Mulloony served on the District of Columbia Police Court during the turbulent days of the women's suffrage

movement when protesters were arrested, brought before the Judge, and then sentenced to jail.

During the 1970s and 1980s, the house was the home of John Chester Culver, who served as a U.S. congressman from Iowa from 1965 to 1975 and as a U.S. senator from 1975 to 1981. He was defeated in 1980 by the current senator, Chuck Grassley. Senator Culver was the roommate of Edward Kennedy while at Harvard and later served as Kennedy's legislative assistant. He was also a eulogist at Kennedy's funeral in 2009. Senator Culver's son, Chet Culver, who was born in Washington, D.C. and spent his childhood in the home at Connecticut and Rosemary, became active in Iowa politics and served as the state's governor from 2007 to 2011.

After being seriously damaged by a fire in 2013, the house was beautifully restored to provide a truly elegant, light-filled home whose open spaces make all who enter feel welcome.

CCHS thanks the McKay family for opening their beautiful home to gala guests, and thanks the hard-working, creative gala co-chairs, Dima Fayyad and Jessica Johnson, and their committee for orchestrating an elegant and fun-filled evening for all.

Recent Acquisitions

"Recent Acquisitions" is a regular feature in the Newsletter, describing documents and other items acquired for the Society's Archive and Research Center

CCHS recently received an outstanding donation of over 200 images documenting the impact of the construction of the Purple Line on the Chevy Chase Lake area. The images were taken by Chevy Chase residents Bill Lebovich and Lars Hanslin between December 2015 and March 2018. Asked to describe their methodology, they wrote: "We started in December, 2015 (at the request of Gail Sansbury) to record the impact of the construction of the Purple Line on the Chevy Chase Lake Area (and the related portions of the Capital Crescent Trail), including the anticipated demolition or major remodeling of existing commercial properties and homes, and, the anticipated construction of new properties. Within these parameters, we divided the area into a group of neighborhoods roughly north of East-West Highway, east and west of Connecticut Ave. and a few blocks south of the Capital Beltway. We then photographed each neighborhood a number of times (through March, 2018) to document conditions prior to and soon after Purple Line construction commencement."

Bill Lebovich is an architectural historian and photographer and Lars Hanslin is a retired attorney for the National Park Service. CCHS could not be happier to have their expertise in recording the impact of the construction project for our Archive! In the coming months the images will be cataloged and made available on the CCHS website for all to see.

Beth graduated from the University of Virginia with a double major in History and Art History. Her academic pursuits and a lifelong love of museums propelled her to undergraduate internships at the Woodrow Wilson Presidential Library and the Gibbes Museum of Art. This work cemented her passion for collections management and archives. She then attended New York University where she received her Master's in Museum Studies.

In her spare time, Beth enjoys reading, attending lectures, and exploring all that the Washington, DC region has to offer. Beth brings important expertise and fresh ideas to CCHS and we look forward to working with her. Please stop by the Center to meet her.
